As Chairman of the Danville Committee of the Republican Party of Virginia, and pursuant to the Plan of Organization and as recommended and directed by the Committee, I, Mark Nicholson, do hereby issue this Call for a Mass Meeting to be held on Tuesday, March 22, 2022 at 6:00 PM at the location of

THE PURPOSE OF THE MASS MEETING is to:

- A. Electing up to 265 Delegates and an equal number of Alternate Delegates to the Fifth Congressional District Republican Convention, to be held on Saturday, May 21 at the Kirby Field House at Hampden-Sydney College at 198 Athletic Center Drive, Farmville, VA 23901, or an alternate site if necessary for the following purposes.
 1. Election of a candidate for the 2022 Congressional Election
 2. Election of a District Committee Chair
- B. Election of the Danville Republican Committee Chairman, Vice Chairman, Secretary, and Treasurer.
- C. Electing members of the Danville Republican Committee.

QUALIFICATIONS FOR PARTICIPATION

All legal and qualified voters of the City of Danville, under the laws of the Commonwealth of Virginia, regardless of race, religion, national origin or sex, who are in accord with the principles of the Republican Party and who, if requested, express in open meeting either orally or in writing as may be required, their intent to support all of its nominees for public office in the ensuing election, may participate as a member of the Republican Party of Virginia in this Danville Republican Committee Mass Meeting.

REGISTRATION

The Mass Meeting shall be called to order at 6:00 PM. For Mass Meeting registration, all participants shall be required to provide proof of identity in the form of a valid government issued photo identification, or by signing an affidavit of identity. Only those individuals who are registered at the Mass Meeting by 6:00 PM on March 22, 2022 or who are in line for registration by that time will be entitled to register and participate in the Mass Meeting.

FIFTH DISTRICT REPUBLICAN CONVENTION FILING REQUIREMENTS

Delegate candidates for election at said mass meeting shall pre-file a separate application for the Fifth District Republican Conventions beginning January 25, 2022, and ending February 22, 2022 at 7:00 PM. Completed applications are to be mailed to Danville Republican Committee PO Box 10344 Danville, VA 24543 or emailed at DanvilleRepubChairman@gmail.com. Postmarks do not govern, and it is the responsibility of the delegate to confirm receipt of application with the Chair. The applications for the Virginia and Fifth District Republican Conventions are attached to this call.

DANVILLE REPUBLICAN COMMITTEE MEMBERSHIP

Candidates for committee membership at said mass meeting shall pre-file the application for membership to the Danville Republican Committee beginning January 25, 2022 and ending March 22,

2022 at 7:00 PM. Completed applications along with membership dues of \$10.00 are to be mailed to PO Box 10344 Danville, VA 24543. Checks need to be made out to the “Danville Republican Committee”. Postmarks do not govern, and it is the responsibility of the prospective member to confirm receipt of application and dues. The membership application is attached to this call.

EXECUTIVE OFFICER FILING REQUIREMENTS – Candidates for Danville Republican Committee Chairman, Vice Chairman, Secretary and Treasurer Candidates at said mass meeting shall file a written statement declaring their intent to run for an executive officer position and submit it by email to DanvilleRepubChairman@gmail.com with cc to DanvilleRepubSecretary@gmail.com. Statements must be received by 5:00 PM on Tuesday, February 8. Postmarks do not govern. It is the responsibility of the candidate to confirm receipt of the declaration with the Chairman. No nominations shall be accepted from the floor of the Mass Meeting.

VOLUNTARY FILING FEES

The Fifth Congressional District Republican Committee is requesting a voluntary \$25 filing fee from all individuals seeking election as a Delegate to the Fifth Congressional District Convention. Checks need to be made out to the “Fifth District Republican Committee”. All filing fees may be mailed to Danville Republican Committee PO Box 10344 Danville, VA 24543.

CANCELLATION

Should fewer than 265 delegates pre-file for the Fifth District Republican Convention, then those candidates shall be duly elected by acclamation. Should only one candidate each properly file for Chairman, Vice Chairman, Secretary, and Treasurer, then those candidates shall be duly elected to their respective positions. The mass meeting may be canceled by the Chairman should all of the above apply. Should the mass meeting be canceled, all delegates to the Fifth District Republican Convention, all individuals who apply to become members of the unit committee and the Unit Chairman will be elected by acclamation.
