As Chairman of the Fluvanna Republican Committee, and pursuant to the Plan of Organization and as recommended and directed by the Committee, I, Darrell Byers, do hereby issue this Call for a Mass Meeting to be held at the

or its alternate site as determined by the Chairman, beginning at **6:30 pm on Monday, March 7, 2022**. Registration begins at 5:30 pm EST. The primary purpose of the Mass Meeting is to:

- 1) Elect a Chairman for the Fluvanna County Republican Committee
- 2) Elect members to the Fluvanna County Republican Committee
- 3) Elect up to 305 Delegates and an equal number of Alternates to the
- 4) Conduct such other business as may properly come before the Mass Meeting.

Its alternate site beginning at 10:00 am for the purpose of:

- a) Election of 5th District Committee Chairman,
 - b) Election of Republican Nominee for US. House of Representatives, and
 - c) Transaction of such other business as may properly come before the Convention.
- Fluvanna County will have 61 Delegate votes at the Convention.

QUALIFICATIONS FOR PARTICIPATION

All legal and qualified voters of Fluvanna County, under the laws of the Commonwealth of Virginia, regardless of race, religion, national origin, or sex, who are in accord with the principles of the Republican Party and who, if requested, express in open meeting either orally or in writing as may be required, their intent to support all of its nominees for public office in the ensuing election, may participate in this Mass Meeting.

MASS MEETING REGISTRATION

For Mass Meeting registration, all participants must be registered voters in Fluvanna County, Virginia, and shall be required to provide proof of identity in the form of a valid government or employer-issued photo identification, or by signing an affidavit of identity, which will be made available upon sign in. Only those individuals who are registered at the Mass Meeting by **6:00 pm local time on March 7, 2022**, or who are in line for registration by that time, will be entitled to register and participate in the Mass Meeting.

Registration Fee for the Fluvanna Republican Committee Mass Meeting: there will be no registration fee required to participate.

PRE-FILING REQUIREMENTS FOR DELEGATE

1. Persons running for Delegate and Alternate to the Republican Party of Virginia 5th Congressional District Convention to be held on May 21, 2022 must submit an Official Delegate Pre-file Form, in person, by email to dbyers2byers203@gmail.com, or by mail to the Committee Chairman, Darrell Byers, Fluvanna Republican Committee PO Box 114 Palmyra VA 22963.
2. The Official Delegate Pre-file form is attached to this call or can be downloaded at the Republican Party of Virginia website, (www.rpv.org), or the 5th District Republican website (<https://5thdistrictva.gop>). All Delegate forms must be received by **6:00 pm local time on Thursday, March 3, 2022**. Postmarks do not govern.
3. A **\$25.00 contribution** is requested, but not required, to help defray the cost of the 5th District Convention. Checks must be **made payable to the 5th District Republican Committee**. The check must be signed by the delegate candidate named on the Delegate form. Delegates contributing the \$25.00 fee will receive an upgraded Convention Kit.

PRE-FILING REQUIRED IF APPLYING FOR FRC MEMBERSHIP

Potential members who wish to be considered at the Mass Meeting must submit an official form and required membership dues of \$15.00 per individual or \$25.00 for couple, by mail to Fluvanna Republican Committee PO Box 114 Palmyra VA 22963, or in person to Darrell Byers, Chairman. The official form can be downloaded at <https://fluvannarepublican.com/join/>. All official forms and the required dues (checks or money orders made payable to Fluvanna Republican Committee) must be received by **6:00 pm. EST, Thursday, March 3, 2022**, and post marks will not govern - after that time, no more membership applications will be allowed for consideration at the Mass Meeting. If the Mass Meeting is canceled the vote to adopt new members will be held at the next FRC meeting.

PRE-FILING REQUIRED FOR CHAIRMAN CANDIDATES

Candidates for Unit Chairman must submit an official form, by mail only, to the Fluvanna Republican Committee Fluvanna Republican Committee PO Box 114 Palmyra VA 22963. The official form can be downloaded at the link provided at <https://fluvannarepublican.com/mass-meeting-info/>. The official form and a non-refundable filing fee of \$50.00 (check or money order made payable to Fluvanna Republican Committee) must be mailed and received by **5:00 pm. EST, February 18, 2022**, and post marks will not govern. Nominations for Unit Chairman will not be permitted from the floor of the Mass Meeting. If there is only one qualified pre-filed candidate for Chairman, then the said candidate will be deemed elected and no voting process will be required at the Mass Meeting and the Mass Meeting may be canceled at the discretion of the FRC Chairman.

PRE-FILING REQUIRED FOR RESOLUTIONS

All proposed resolutions must be received in typed format, by mail only, to the Fluvanna Republican Committee **Fluvanna Republican Committee PO Box 114 Palmyra VA 22963**. All proposed resolutions must be mailed and received by **6:00 pm EST, Thursday March 3, 2022**, and post marks will not govern. If the Mass Meeting is canceled, all submitted Resolutions will be presented at the next FRC Meeting.

CANCELLATION NOTIFICATION

Should only one candidate file for the FRC Chairman position and no more than 305 Delegates file for the 5th District Convention, the Mass Meeting may be canceled by the Chairman and the candidate for Chairman and the Delegates will be considered elected.
