

OFFICIAL CALL

Mass Meeting of Charlottesville Committee of the Republican Party of Virginia

As Chairman of the Charlottesville Committee of the Republican Party of Virginia, and pursuant to the Plan of Organization and as recommended and directed by the Committee, I, Daniel Moy, do hereby issue this call for a **Mass Meeting to be held at the Circuit Court of Charlottesville, 315 E. High Street, Charlottesville, VA 22902, starting at 11:30 A.M (11:00 A.M. check-in) local time on Saturday, March 26, 2022** for the following purposes:

- A. Electing a Chairman for the Charlottesville Republican Committee
- B. Electing the members of the Charlottesville Republican Committee
- C. Electing up to 145 Delegates (and an equal number of Alternates) to the Republican Party of Virginia's 5th District Convention, to be held on Saturday, May 21, 2022 at the Kirby Field House at Hampden-Sydney College or its alternate site, beginning at 10:00 A.M. local time for the following purposes:
 - a. Nominating a Republican candidate for the United States House of Representatives;
 - b. Electing a Chairman for the 5th Congressional District Republican Committee
 - c. And for the transaction of such other business as may properly come before the convention

The Charlottesville Committee is entitled to 29 Delegate Votes at the District Convention. The published 5th District Convention call is hereby incorporated in its entirety into this call. See <https://5thdistrictva.gop/convention/>

D. And for the transaction of such other business as may properly come before the mass meeting.

Qualifications for Participation

All legal and qualified voters of the City of Charlottesville under the laws of the Commonwealth of Virginia, regardless of race, religion, national origin or sex, who are in accord with the principles of the Republican Party and who, if requested, express in open meeting either orally or in writing as may be required, their intent to support all of its nominees for public office in the ensuing election, may participate as members of the Republican Party of Virginia in its mass meetings, party canvasses, conventions or primaries encompassing their respective election districts.

Pre-Filing Requirements

1. Candidates for the election at the Mass Meeting for the Chairman of the Charlottesville Republican Committee shall file a written statement by mail or in person to **Jim Moore, 1213 Hazel Street, Charlottesville, VA 22902** or email to charlottesvilleGOP@gmail.com which must be received not later than **Thursday, March 24, 2022 at 6:00 P.M.** Post marks (and email time stamps) will not govern. Jim Moore can be reached by phone at 540-218-5886. As a backup, the Unit Chair can be reached at 703-298-9497. Nominations for Chairman from the floor during the Mass Meeting will not be accepted unless no candidate for Chairman files by the deadline.

2. Candidates for Delegate or Alternate to the 5th District Convention may pre-file the official Delegate Form approved by the District Committee (see link below) by mail or in person to **Jim Moore, 1213 Hazel Street, Charlottesville, VA 22902** or by email to charlottesvilleGOP@gmail.com not later than **Thursday, March 24, 2022 at 6:00 PM.** Post marks (and email time stamps) will not govern. **Delegate forms may also be hand carried to the Mass Meeting** and will be received during the check-in period between 11:00

Convention Registration Fee

To help defray the cost of the convention, the 5th District Committee is requesting a voluntary \$25 contribution from individuals seeking election as a Delegate to the May 21st 5th District Convention. Checks should be made payable to “5th District Republican Committee” and signed by the delegate candidate; the Charlottesville Committee will submit the checks received to the District Committee. Military Members as Delegates

Military Members (any members of the Virginia National Guard, or the United States Armed Forces, Merchant Marine, or Coast Guard currently serving on active duty) who comply with these filing requirements shall not be required to be elected, but shall be declared delegates pursuant to Article VIII, Section H of the Plan of Organization of the Republican Party of Virginia.

Military Member delegates or alternate delegates that are unable to attend the convention in person due to obligations of their official military orders, shall have their votes cast within the Charlottesville delegation according to candidate preference ballot. Instructions regarding the casting of candidate preference ballots are available in the Call for the Fifth District Republican Convention, which is available on the websites of the Republican Party of Virginia at www.virginia.gop, and the Fifth District Republican Committee at <https://5thdistrictva.gop>.
