

**OFFICIAL CALL**  
**Mass Meeting**  
**Nelson County Republican Committee**  
**Of the Republican Party of Virginia**  
**MAY 20, 2023**

As Chairman of the Nelson County Committee of the Republican Party of Virginia, and pursuant to the Plan of Organization and as recommended and directed by the Nelson County Republican Committee, I, R. Carlton Ballowe, do hereby issue this call for a Mass Meeting to be held at the Nelson United Methodist Church, 5239 Thomas Nelson Highway, Arrington, VA 22922 beginning at 11:00 AM local time on May 20, 2023. Doors will open and registration will begin at 10:00 AM.

This meeting is called for the following purposes:

- To nominate Republican Candidates for the following offices of the County of Nelson:
  - Commonwealth's Attorney
  - Sheriff
  - Clerk of the Circuit Court
  - Commissioner of the Revenue
  - Treasurer
  - South District Member of the Board of Supervisors

Successful Candidates will be the Republican Nominees voted for in the Virginia General Election on November 7, 2023.

- For the transaction of such other business as may properly come before the Mass Meeting.

**Qualifications for Participation:**

All legal and qualified voters of the Nelson County Virginia under the laws of the Commonwealth of Virginia, regardless of race, religion, national origin or sex, who are in accord with the principles of the Republican Party and who, if requested, express in open meeting either orally or in writing, as may be required by their Republican unit committee, their intent to support all of its nominees for public office in the ensuing election, may participate as members of the Republican Party of Virginia in this Nelson County Republican Committee Mass Meeting. Registered minors who will be 18 years of age by November 7, 2023, may qualify to vote in this Mass Meeting.

Mass Meeting participants must present one of the forms of identification listed in § 24.2-643 of the Code of Virginia in order to participate.

A voluntary fee of \$20.00 is requested, but not required, to offset the cost of the Mass Meeting.

### **Constitutional Officer Filing Requirements:**

Candidates for nomination for the Constitutional Office of Commonwealth's Attorney, Sheriff, Clerk of the Circuit Court, Commissioner of the Revenue or Treasurer shall file the completed and signed Candidate Pre-File form attached to this call along with the required, non-refundable filing fee of \$500.00 made payable to NCRC via USPS to NCRC, P. O. Box 75, Lovingston, VA 22949-0075 no later than Friday, May 12, 2023 at 2:00 PM. Postmarks will not govern. It is the responsibility of the candidate to confirm receipt of their Candidate Pre-File Form by the Nelson County Republican Committee

If more than one candidate pre-files for any Constitutional Office, an election will be held by secret ballot to determine the nominee. If no more than one **QUALIFIED** candidate pre-files for any Constitutional office, that candidate will be deemed to have been nominated. Nominations will not be taken from the floor for any Constitutional Office.

### **Board of Supervisor Filing Requirements:**

Candidates for nomination for the South Board of Supervisors seat shall file the completed and signed Candidate Pre-File form attached to this call along with the required, non-refundable filing fee of \$100.00 made payable to NCRC via USPS to NCRC, P. O. Box 75, Lovingston, VA 22949-0075 no later than Friday, May 12, 2023 at 2:00 PM. Postmarks will not govern. It is the responsibility of the candidate to confirm receipt of their Candidate Pre-File Form by the Nelson County Republican Committee

If more than one candidate pre-files for the South District seat, an election will be held by secret ballot to determine the nominee. If no more than one **QUALIFIED** candidate pre-files for the South District Supervisor seat, that candidate will be deemed to have been nominated. Only registered voters within the South district will be able to vote on the contenders within that District. Nominations will not be taken from the floor for this Supervisor seat.

### **Military Members as Participants:**

Any member of the Virginia National Guard, United States Armed Forces, Merchant Marine, or Coast Guard currently serving on active duty who meets the requirements outlined under **Qualifications for Participation** and unable to attend in person may participate in this Mass Meeting by submitting a candidate preference ballot pursuant to Article VIII, Section H paragraphs 6 & 7 of the Virginia Republican Party Plan.

Candidate preference ballots will be made available by the Nelson County Republican Committee no later than May 13, 2023, and posted at <https://nelsoncountyrepublicans.com/> and <https://5thdistrictva.gov> or, upon request, by e-mailing: [nelsoncountygop@hotmail.com](mailto:nelsoncountygop@hotmail.com). Candidate preference ballots must be returned no later than Friday, May 19, 2023 at 2:00PM, by email to [nelsoncountygop@hotmail.com](mailto:nelsoncountygop@hotmail.com) or via USPS at NCRC, P. O. Box 75, Lovingston, VA 22949-0075.

#### **Cancellation:**

If not more than the number of persons to be nominated for any office properly file, then such properly filed, **QUALIFIED** person shall be declared the Republican nominee and no election will occur for that office. Should all elections be cancelled, the Mass Meeting may also be cancelled. A notice of cancellation will be posted on the website of the Republican Party of Virginia <https://virginia.gov/>, the 5th District website at <http://5thdistrictva.gov> and the Nelson County Republican Committee website at: <http://nelsoncountyrepublicans.com>

No Resolutions may be presented at this meeting.
