As Chairman of the Lynchburg Republican City Committee ("LRCC"), pursuant to the

Republican Party of Virginia Plan of Organization, and as recommended and directed by the LRCC, I, Veronica Bratton, do hereby issue this call for a Mass Meeting to be held at 122 Fleetwood Dr, Lynchburg, VA 24501, Lynchburg, VA 24502 on Saturday March 23, 2024, registration beginning at 9:00AM and meeting beginning at 10:00AM, or at an alternate location, date and/or time for the following purposes:

- 1. Elect a chairman of the Lynchburg Republican City Committee for the 2024-2026 term.
- 2. Elect the members of the Lynchburg Republican City Committee for the 2024-2026 term.
- 3. Elect up to 615 Delegates and up to an equal number of Alternate Delegates to the Fifth District Republican Convention to be held April 27, 2024, at 10:00 a.m. or alternate date, at Drakes Branch Volunteer Fire Department, 4801 Drakes Main Street, Drakes Branch, VA 23937 or an alternate site if necessary for the following purposes:
 - a. Election of Fifth District Republican Committee Chairman
 - b. Election of three (3) State Central Committee Members
 - c. Election of one (1) Elector for the 2024 Presidential Election
 - d. Transaction of such other such business as may properly come before the Convention.
- 4. Elect up to 615 Delegates to the Republican Party of Virginia 2024 Quadrennial Convention to be held from May 31-June 1, 2024 at Hampton Roads Convention Center, 1610 Coliseum Drive, Hampton, VA 23666. Convening on May 31, 2024, at 2 p.m. and June 1, 2024, at 10 a.m. for the following purposes:
 - a. Selecting two (2) Electors At-Large to be voted for in the presidential election on November 5, 2024
 - b. Electing a State Chairman
 - c. Nominating a National Committeeman and National Committeewoman
 - d. For the transaction of such other business as may properly come before the Convention
- 5. For the transaction of other such business as may properly come before the Mass Meeting.

QUALIFICATIONS FOR PARTICIPATION

All legal and qualified voters in the City of Lynchburg under the laws of the Commonwealth of Virginia, regardless of race, religion, national origin or sex who are in accord with the principles

of the Republican Party and who, if requested, express in open meeting either orally or in writing as may be required their intent to support all of its nominees for public office in the ensuing election may participate as members of the Republican Party of Virginia in this Mass Meeting as well as District or State Conventions subject to the provisions of the "Call" and Article 1 of the Plan of Organization.

In addition to the foregoing, to be in accord with the principles of the Republican Party, a person otherwise qualified hereunder shall not have participated in Virginia in a nomination process of a party other than the Republican Party within the last five (5) years. A single exception shall be a voter who renounces affiliation with any other party in writing and who expresses in writing that he/she is in accord with the principles of the Republican Party and intends, at the time of writing, to support the nominees of the Republican party in the future. Any voter who utilizes the foregoing exception, and thereafter participates in the nomination process of a party other than the Republican Party, shall not have the benefit of the exception thereafter. Within 30 days of receipt, the Official Committee shall provide a copy to the signed renunciation statement to the Republican Party of Virginia, to be maintained for a period of five (5) years.

Mass Meeting participants must present a valid form of photo identification in order to participate.

A voluntary fee of \$20.00 is requested to participate in this Mass Meeting

A mandatory registration fee of \$20.00 is required for Delegates to the 5th District Convention A mandatory registration fee of \$45.00 is required for Delegates to the State Convention Doors will open at 9am and voting will begin at 10am. Must be checked in or in line to check in by 10am in order to vote.

No proxies will be permitted.

MILITARY MEMBERS AS DELEGATES TO MASS MEETINGS, DISTRICT AND/OR STATE CONVENTIONS

Military Members (any members of the Virginia National Guard, or the United States Armed Forces, Merchant Marine or Coast Guard currently serving on active duty) may be certified as delegates by complying with the procedures detailed in a Unit's call pursuant to Article VIII, Section H, paragraph 6. Military Members serving as delegates who are unable to attend the conventions/Mass Meeting in person due to obligations of their official military orders, shall have their votes cast within their unit delegation according to candidate preference ballots. Request for candidate preference ballots must include evidence of active duty status. Candidate preference ballots for this Mass Meeting will be made available by the Lynchburg Republican City Committee by request to <u>lynchburgrepublicancc@gmail.com</u> no later than March 11, 2024. Candidate preference ballots must be returned to LRCC, PO Box 12237, Lynchburg, VA 24502 no later than March 16, 2024. Candidate preference ballots for Fifth Congressional District elections will be made available by the Fifth District Committee no later than Saturday, April 6, 2024 and will be made available on the Fifth District Republican Committee website, or upon request, by nancyrodland2016@gmail.com

Completed preference candidate ballots must be received by the Recording Secretary no later than Saturday April 20, 2024 by email or by physical delivery to PO Box 75, Lovingston, VA 22949.

Candidate preference ballots for the State Convention shall be made available on the RPV website no later than May 11, 2024 and must be returned to militaryballot@virginia.gop no later than May 28, 2024.

FILING REQUIREMENTS FOR COMMITTEE MEMBERSHIP

Candidates for election as a member of the Lynchburg Republican City Committee must file the completed Membership Application Form with an original signature and include a check for evidence of payment of a \$25.00 membership fee. The form and payment must be mailed to LRCC, PO Box 12237, Lynchburg, VA 24503, or by physical delivery to Soundz Hearing, 1319A Enterprise Dr, Lynchburg, VA 24502 between the hours of 9am-5pm Monday-Friday by 5:00pm Friday March 15, 2024. Membership applications received after March 15, 2024 will be voted on at the first regular committee meeting following the Mass Meeting. Postmarks do not govern.

Candidates for election as Chair of the Lynchburg Republican City Committee **must** prefile the completed and signed Declaration of Candidacy Form attached to this call by 5pm, March 15, 2024 and shall include a check or evidence of payment of a \$200.00 filing fee to LRCC, PO Box 12237, Lynchburg, VA 24506 or by physical delivery to Betty Gibbs by reaching her at <u>bettyisbusy@gmail.com</u> to arrange the delivery. Postmarks do not govern.

No nominations for committee chair from the floor will be considered. The successful candidate for chair must win by a majority vote.
