# OFFICIAL CALL TO MASS MEETING Campbell County Republican Committee of the Republican Party of Virginia

As Chairman of the Campbell County Republican Committee, and pursuant to the Plan of Organization of the Republican Party of Virginia, and as recommended and directed by the Committee, I, Doug Barringer, do hereby issue this call for a Mass Meeting to be held in the Rustburg High School Auditorium, 1671 Village Hwy, Rustburg, VA, at 10:00 AM local time on Saturday, March 23, 2024, with check-in to begin at 8:30 AM local time, for the following purposes:

- 1. Electing a Unit Chairman and electing up to 790 members to the Unit Committee;
- 2. Electing up to 790 Delegates and an equal number of Alternates from Campbell County to the District Convention of the 5<sup>th</sup> Congressional District, to be held on Saturday, April 27, 2024, beginning at 10:00 AM, at Drakes Branch Volunteer Fire Department, 4801 Drakes Main Street, Drakes Branch, VA, 23937 for the purposes of
  - a) Election of Fifth District Committee Chairman
  - b) Election of three (3) State Central Committee Members
  - c) Election of one (1) Elector for the 2024 Presidential Election
  - d) Transaction of such other business as may properly come before the Convention.
- 3. Electing up to 790 Delegates and an equal number of Alternate Delegates to the Virginia Republican Convention, to be held on May 31 to June 1 at the Hampton Roads Convention Center, 1610 Coliseum Drive, Hampton, VA 23666, or an alternative site, if necessary, for the following purposes of
  - a) Election of a State Committee Chair
  - b) Election of a National Committeeman and Committeewoman
  - c) Election of two (2) Presidential Electors for the Electoral College
  - d) Transaction of such other business as may properly come before the Convention.

Fully qualified voters in line to check-in by 10:00 AM local time may participate in the Mass Meeting. Voters not in line by 10:00 AM local time may not participate in the Mass Meeting.

# **Qualifications for Participation**

All legal and qualified voters of Campbell County under the laws of the Commonwealth of Virginia, regardless of race, religion, national origin or sex, who are in accord with the principles of the Republican Party and who, if requested, express in open meeting either orally or in writing as may be required, their intent to support all of its nominees for public office in the ensuing election, may participate as members of the Republican Party of Virginia, and may participate in this Mass Meeting, subject to the provisions in Article I of the RPV Plan of Organization.

In addition to the foregoing, to be in accord with the principles of the Republican Party, unless otherwise stipulated by the appropriate Official Committee, a person otherwise qualified hereunder shall not have participated in Virginia in the nomination process of a party other than the Republican Party within the last five years.

In accordance with the Republican Party of Virginia Plan of Organization, a single exception to this shall be approved for a voter who renounces affiliation with any other party in writing, and who expresses in writing that he/she is in accord with the principles of the Republican Party and intends, at the time of this writing, to support the nominees of the Republican Party in the future. Any voter that utilizes the forgoing exception, and thereafter participates in the nomination process of a party other than the Republican Party, or supports a candidate other than the Republican nominee(s), shall not have the benefit of the exception thereafter.

All persons seeking to participate in the Mass Meeting must present one of the forms of identification listed in § 24.2-643 of the Code of Virginia in order to participate. Specific information can be found at the link below.

# **Candidate Filing Requirements**

Candidates for election or nomination at this Mass Meeting shall file a written statement with Doug Barringer, Chairman, by postal delivery to P.O Box 1213, Rustburg, VA 24588, or by physical delivery to 277 Holland Ct, Rustburg, VA. The written statement and required fees must be received by the deadlines specified below; postmarks are not evidence of receipt by the deadline. The statement must be made on an official filing form, which is attached to this Official Call. Candidates for election as Unit Chair must file this written statement by 5:00 PM EST on March 19, 2024 and shall include with their written statement a check or evidence of payment of a \$200.00 filing fee, made payable to the Campbell County Republican Committee. If only one candidate pre-files for the office of Unit Chair, that candidate shall be deemed to be elected by default.

Candidates for election to voting membership in the Campbell County Republican Committee must file this written statement by 5:00 PM EDT on March19, 2024 and shall include with their written statement a check or evidence of payment of a \$30.00 filing fee for a two-year term, made payable to the Campbell County Republican Committee. As many as 790 individuals can pre-file for election to voting membership. If fewer than 790 applicants pre-file, all applicants who pre-file shall be deemed to be elected by default.

Candidates for election as Delegate or Alternate Delegate to the 2024 District Convention of the 5<sup>th</sup> Congressional District must print and complete the official Delegate File Form, available at <a href="http://www.5thdistrictva.gop/resources/Documents/Pre-file-Form-Template-Unit.pdf">http://www.5thdistrictva.gop/resources/Documents/Pre-file-Form-Template-Unit.pdf</a>, and file this written statement by 5:00 PM EDT on March 19, 2024. Every person elected as a Delegate or an Alternate Delegate to the Convention shall pay a mandatory registration fee of \$20.00 to the Campbell County Republican Committee. The Campbell County Republican Committee will then write a single check to the Fifth Congressional District, conveying the sum of all registration fees collected. As many as 790 Campbell County Republicans can be elected to

serve as Delegates, and 790 more can be elected to serve as Alternate Delegates, to the 5<sup>th</sup> Congressional District Republican Convention. If fewer than 790 applicants pre-file to serve as Delegates, all applicants who pre-file shall be deemed to be elected as Delegates by default. If more than 790 applicants pre-file to serve as Delegates, then the Mass Meeting shall elect 790 to serve as Delegates, and as many as 790 others to serve as Alternate Delegates.

Candidates for election as Delegate or Alternate Delegate to the 2024 Convention of the Republican Party of Virginia must print and complete the official Delegate File Form and file the attached delegate filing form by 5:00 PM EDT on March 19, 2024. Every person elected as a Delegate or an Alternate Delegate to the Convention shall pay a mandatory registration fee of \$45.00 to the Campbell County Republican Committee. The Campbell County Republican Committee will then write a single check to the Fifth Congressional District, conveying the sum of all registration fees collected. As many as 790 Campbell County Republicans can be elected to serve as Delegates, and 790 more can be elected to serve as Alternate Delegates, to the 2024 Convention of the Republican Party of Virginia. If fewer than 790 applicants pre-file to serve as Delegates, all applicants who pre-file shall be deemed to be elected as Delegates by default. If more than 790 applicants pre-file to serve as Delegates, then the Mass Meeting shall elect 790 to serve as Delegates, and as many as 790 others to serve as Alternate Delegates.

It is the responsibility of the candidate or delegate to confirm receipt of all declarations by the Campbell County Republican Committee Chairman. All forms submitted to Campbell County Republican Committee must contain the signature of the applicant. Applicants are also encouraged to provide working phone number(s) and email address(es) for notification and verification purposes.

# **Military Members as Delegates**

Military Members (any members of the Virginia National Guard, or the United States Armed Forces, Merchant Marine, or Coast Guard currently serving on active duty) who comply with these filing requirements shall not be required to be elected, but shall be declared delegates pursuant to Article VIII, Section H. of the Plan of Organization of the Republican Party of Virginia.

Military Member delegates or alternate delegates that are unable to attend the convention in person due to obligations of their official military orders, shall have their votes cast within their unit delegation according to candidate preference ballots. Instructions regarding the casting of candidate preference ballots are available in the Call for the Convention, which is available on the website of the Republican Party of Virginia <a href="https://virginia.gop">https://virginia.gop</a> and <a href="https://www.5thdistrictva.gop">https://www.5thdistrictva.gop</a>.

### **Cancellation**

If not more than the number of persons seeking to be nominated or elected shall file for any office, then such properly filed persons shall be declared nominated or elected as the case may be, and no election for that office will occur at the Mass Meeting. Should it not be necessary to contest the nomination or election for any Offices at the Mass Meeting, the Mass Meeting will be

cancelled. A notice of cancellation will be posted on the website of the Republican Party of Virginia <a href="http://virginia.gop">http://virginia.gop</a> and <a href="http://www.5thdistrictva.gop/">http://www.5thdistrictva.gop/</a>.
