**This form must be mailed or physically delivered to Chairman Doug Barringer at 277 Holland Ct, Rustburg, VA 24588 on or before March 19, 2024 5:00 PM EDT for Committee Chairman and/or for Committee Membership. Postmarks do not govern. Electronic signatures shall not be accepted.**

\*Note: The State Party Plan of the Republican Party of Virginia does allow a voter who participated in another party's nomination process in the past five years to renounce affiliation with any other party in writing, and express in writing that he/she is in accord with the principles of the Republican Party and intends to support the nominees of the Republican Party in the future. People wishing to renounce their affiliations with other parties MUST complete a written renunciation, which will be subject to public scrutiny at the Mass Meeting. In accordance with the State Party Plan, Mass Meeting Members may choose to elect or reject any person seeking election to the Committee. Written renunciations will become part of the permanent public records of the Republican Party, regardless of the Mass Meeting Members' election or rejection of the person making the renunciation. A second violation of the above oath is a lifetime disqualification from participation in Republican Party functions.
