

OFFICIAL CALL
Party Canvass
of the Hanover County Republican Committee
of the Republican Party of Virginia

As Chairman of the Hanover County Republican Committee of the Republican Party of Virginia, and pursuant to the Plan of Organization and as recommended and directed by the Committee, I, Jack Dyer, do hereby issue this call for a **Party Canvass to be held at Hanover County Administration Building, 7516 County Complex Rd., Hanover, VA., with voting starting at 6:00 PM and ending at 8:00PM local time on Thursday, February 29, 2024** for the following purposes:

- a) Electing a Chairman for the Hanover County Republican Committee
- b) Electing the members to the Hanover County Republican Committee
- c) Elect up to 325 Delegates and an equal number of Alternates to the Republican Party of Virginia 5th Congressional District Convention to be held on April 27, 2024 at 10:00 am at the Drakes Branch Volunteer Fire Department, 4801 Drakes Main Street, Drakes Branch, VA 23937, or an alternate site if necessary. The purpose of the Convention is:
 - a. Election of Fifth District Republican Committee Chairman,
 - b. Election of three (3) State Central Committee Members, and
 - c. Election of one (1) Elector for the 2024 Presidential Election.
 - d. Transaction of such other business as may properly come before the Convention
- d) Elect up to 1450 Delegates and an equal number of Alternates to the Republican Party of Virginia 1st Congressional District Convention to be held on May 4, 2024 at 10:00 am at King William High School, 80 Cavalier Drive, King William, VA 23086-3657, or an alternate site if necessary. The purpose of the Convention is:
 - a. Electing a District Chairman of the Republican Party,
 - b. Electing three (3) Members of the State Central Committee, and
 - c. Election of one (1) Elector for the 2024 Presidential Election.
 - d. For the transaction of such other business as may properly come before the Convention
- e) Electing up 1675 Delegates and an equal number of Alternates to the Republican Party of Virginia Quadrennial State Convention to be held on May 31-June 1, 2024 at the Hampton Roads Convention Center, 1610 Coliseum Dr, Hampton VA 23666 at 2:30 PM on May 31 and 10:00 AM on June 1 for the following purposes:
 1. Nominating two Electors At-Large to be voted for in the presidential election on November 5, 2024;
 2. Electing a State Chairman;
 3. Nominating a National Committeeman and National Committeewoman; and
 4. for the transaction of such other business as may properly come before the State Convention.

For the State Convention, each unit is entitled to one (1) Delegate Vote per 250 Republican votes for President and Governor at their last election, so that the Hanover County Republican Committee is entitled to three hundred thirty-five (335) Delegate Votes.

Qualifications for Participation

All legal and qualified voters of Hanover County, under the laws of the Commonwealth of Virginia, regardless of race, religion, national origin or sex, who are in accord with the principles of the Republican Party and who, if requested, express in open meeting either orally or in writing as may be required, their intent to support all of its nominees for public office in the ensuing election, may participate as members of the Republican Party of Virginia in its mass meetings, party canvasses, conventions or primaries encompassing their respective election districts.

All individuals desiring to participate in the party canvass shall be required to present some form of photo identification such as a valid driver's license, or other positive identification.

A voter who, subsequent to making a statement of intent, publicly supports a candidate in opposition to a Republican nominee shall not be qualified for participation in party actions, as defined in Article I of the Party Plan of the Republican Party of Virginia, for a period of four (4) years.

A person otherwise qualified shall not have participated in Virginia in the nomination process of a party other than the Republican Party within the last five years. A single exception shall be approved for a voter that renounces affiliation with any other party in writing, and who expresses in writing that he/she is in accord with the principles of the Republican Party and intends, at the time of the writing, to support the nominees of the Republican Party in the future. Any voter that utilizes the foregoing exception, and thereafter participates in the nomination process of a party other than the Republican Party, shall not have the benefit of the exception identified in this paragraph thereafter.

Filing Requirements

Candidates for the position of Unit Chairman of the Hanover County Republican Committee must submit the attached chairman filing form by mail or in person, with a registration non-refundable fee of \$500.00 payable to the Hanover County Republican Committee, to **HCRC Treasurer, PO Box 6617, Glen Allen VA 23058 or 14168 Windmill Dr., Montpelier VA 23192** no later than **February 16, 2024 at 5:00 PM. Postmarks do not govern.** Said form is attached to this Call and may be obtained at www.hanovergop.com and must be fully completed and signed by the candidate in order for that candidate to be deemed properly filed.

If there is no more than one properly filed candidate meeting the foregoing requirements, then said candidate may be declared the chairman.

Candidates for membership of Hanover County Republican Committee must submit the attached delegate/member filing form (with appropriate box checked) and fee by mail or in person to **HCRC Treasurer, PO Box 6617, Glen Allen VA 23058 or 14168 Windmill Dr., Montpelier VA 23192** no later than **February 21, 2024 at 5:00 PM. Postmarks do not govern.** Said form is attached to this Call and may be obtained at www.hanovergop.com and must be fully completed and signed by the candidate in order for that candidate to be deemed properly filed. The fee can be paid online at www.hanovergop.com.

If the candidate for membership is a current member of the Hanover Republican Committee and does not wish to be a delegate to the 1st District, 5th District or RPV State Conventions, they can sign up online at www.hanovergop.com before **February 21, 2024 at 5:00 PM.** In that case, the delegate/member filing form is not required.

Candidates for election as Delegates (and Alternates) to the May 4th 1st Congressional District Convention and/or Delegates (and Alternates) to the May 31st -June 1st RPV Quadrennial State Convention must submit the attached delegate/member filing form (with appropriate boxes checked) and fee by mail or in person to **HCRC Treasurer, PO Box 6617, Glen Allen VA 23058 or 14168 Windmill Dr., Montpelier VA 23192** no later than **February 21, 2024 at 5:00 PM. Postmarks do not govern.** Said form is attached to this Call and may be obtained at www.hanovergop.com and must be fully completed and signed by the candidate in order for that candidate to be deemed properly filed.

Candidates for election as Delegates (and Alternates) to the April 27th 5th Congressional District Convention must submit the 5th District specific filing form that can be found on the Republican Party of Virginia website (RPV.org) and fee by mail or in person to **HCRC Treasurer, PO Box 6617, Glen Allen VA 23058 or 14168 Windmill Dr., Montpelier VA 23192** no later than **February 21, 2024 at 5:00 PM. Postmarks do not govern.**

If the number of member and delegate candidates filed do not exceed the maximum numbers allowed for their respective positions, all properly filed candidates meeting the foregoing requirements for member and delegate may be declared as elected.

Registration Fees

There is no registration fee to participate in this party canvass, but the annual dues of Thirty-Five dollars (\$35) is required to become a member of Hanover County Republican Committee.

For the 5th District Convention, a fee of Twenty dollars (\$20) to help cover the Convention expenses is required of each person standing for election as a delegate or alternate delegate to the 5th District Convention.

For the 1st District Convention, a fee of Ten dollars (\$10) to help cover the Convention expenses is required of each person standing for election as a delegate or alternate delegate to the 1st District Convention.

For the Republican Party of Virginia Quadrennial Convention, a fee of Forty-Five dollars (\$45) to help cover the Convention expenses is required of each person standing for election as a delegate or alternate delegate to the RPV Quadrennial Convention.

Cancellation / Alternate Date or Location

If after consideration of all filings it is found that no election business exists for the Party Canvass, the Party Canvass may be canceled after the filing deadlines under the authority of the Chairman of the Hanover County Republican Committee by notice methods commensurate with the original publication of the call. The Chairman of the Hanover County Republican Committee may move the Party Canvass to an alternate location, date and time upon significant hazard or unavailability of the primary location, date and time.
